Candidates with any certificates, documents or publications considered useful for the purposes of competition procedures and whenever an evaluation of the same are expressly stipulated as part of the selection procedure indicated in art. 1 for each PhD Programme of a Doctoral School, must attach the following certificates, documents and publications to the application:

- 1) curriculum of their research and teaching activities;
- 2) certificates and documents considered useful for the purposes of evaluation;
- 3) letter/letters of recommendation (in accordance with the form attached A to this application procedure);
- 4) academic publications and corresponding list, presented in original version, or authenticated copy or as a photocopy. In the event of the latter, the candidate must state that the photocopy conforms to the original document;
- 5) (only candidates holding a foreign academic qualification) description of the Degree with a list of exams.

Publications in languages other than English, Italian, French, German and Spanish, or those which do not include a summary in one of the abovementioned languages, must be produced in the original language and translated into Italian.

Certificates issued by the competent authority of the State of which the foreign candidate is a citizen must comply with the provisions in force in the same State and furthermore must be translated and authenticated by the competent Italian consular authorities.

An Italian translation of all certificates and documents written in a foreign language must be attached, certified as conforming to the foreign text, and issued by the competent Italian consulate or diplomatic representative or alternatively by an official translator.

Documents, certificates and publications forwarded in accordance with art. 2 and 3 can be collected from the Postgraduate/State Examinations office from 1 June to 31 July 2008.

Documents, certificates and publications that are not collected within the abovementioned time limits will no longer be available.

ARTICLE 4 – Selection Committee

Each committee responsible for the evaluation of candidates will be appointed by decree of the Rector and will be composed of three permanent members and two substitute members, chosen from tenured university professors and researchers also from other Italian or foreign Universities, specialised in the disciplines relating to the disciplinary areas covered in the Programme/School. No more than two additional experts, who may also be foreign, can be chosen from public and private research bodies or institutions.

ARTICLE 5 – Admissions procedures

The selection procedure and the exam schedule, where required, are indicated in art. 1, in the sections relating to each Doctoral School Programme.

Where specified in the selection procedure, the interview will include a test of knowledge of English and another optional foreign language if requested by the candidate when submitting his/her application.

In the event of selection procedures requiring exam(s) or requiring academic and research record and exam(s), candidates will be admitted subject to presentation of a valid ID.

ARTICLE 6 – Ranking

At the end of the selection procedure, each commission will draw up the final meritbased ranking of candidates.

The final ranking will be approved by the Decree of the Rector, once all the documentation has been declared valid.

Candidates will be admitted to the Programmes according to the order of the final ranking and until all the places available under the application procedure have been allocated for each Programme.

The final rankings will be publicly announced:

- on the official University notice board;
- on the University website at http://www.unimore.it, under: "Offerta formativa" / "Dottorati di ricerca".

In the event a candidate qualifies for a place in more than one ranking, he/she may only enrol in one PhD Programme.

Candidates are not permitted to enrol in a PhD Programme of a Doctoral School if they are already enroled in another PhD Programme, Doctoral School, degree or diploma course or Specialisation course and I and II level Masters at the University of Modena and Reggio Emilia or any other University.

The following additional candidates may be admitted to fill up to 100% of the ordinary places available:

- candidates who are eligible according to the final ranking and who are receiving "assegni di ricerca" (research grants) but who are not among the available places winners;

- non-EU candidates, eligible for the final ranking, who have been awarded study scholarships funded by the Italian Government or by the Government of their country of origin;
- candidates from Countries which have entered into a specific intergovernmental agreement, followed by a special convention with the University (not involving a compulsory financial burden for the University of Modena and Reggio Emilia).

ARTICLE 7 - Enrolment

Within the mandatory twelve-day time limit, starting from the day following that of the publication of the final rankings on the official University notice board, those candidates qualifying for a place in the final merit-based ranking must enrol in the first year of the PhD Programme in one of the following ways. Failure to comply will result in loss of right to admission:

- via Internet:

through the University website at page http://www.esse3.casa.unimore.it/Start.do (select 'Login' and, using the username and password assigned when registering for the competition, or alternatively those already held when enrolled as a student at the University of Modena and Reggio Emilia, follow the instructions in the Student section: "Immatricolazione" – "Enrolment in courses and planned access according to ranking"; in the event that username and/or password are forgotten, send an e-mail to webhelp@unimore.it for assistance);

- via the mechanised self-service facilities: using your tax identification number (codice fiscale).

For both of the methods indicated above, candidates who qualify for a place in the final merit-based ranking must confirm the details previously entered when submitting the admission application and print out the following documentation:

- a) application for matriculation;
- b) any other documentation necessary for matriculation (different for PhD students receiving or not receiving scholarships).

Payment of the government tax stamp ("marca da bollo"), the first instalment of the fees, and a printout of the abovementioned documentation alone are insufficient for the completion of enrolment in a PhD Programme.

Candidates must in fact submit the following documentation to the Postgraduate/State Examinations office (Via Università no. 4, 41100 – Modena) BY HAND during public opening hours (Monday and Wednesday from 3 to 5 P.M.; Tuesday, Thursday and Friday from 11 A.M. to 1:30 P.M.), or REGISTERED MAIL, or COURIER (the date of receipt of the package by the University Administration will be considered and not that of dispatch) within the mandatory twelve-day time limit, starting from the day following that of publication of the final rankings. Failure to comply will result in loss of the right to enroll:

- a) application for matriculation;
- b) additional statement form with recent, passport-sized photograph;
- c) receipts for payment of the government tax stamp ("marca da bollo") for € 14.62 (by all candidates) and the first instalment of fees (for those who have not been awarded a scholarship);
- d) photocopy of a valid identity document, duly signed;
- e) photocopy of the tax identification card ("codice fiscale");

f) receipt for the payment of € 25.00 made to participate in the competition in accordance with art. 3.

Italian nationals and foreigners holding a foreign academic qualification must present their degree certificates with a list of exams taken complete with Italian translation, authentication and "declaration of validity" supplied by the Italian consulate or diplomatic representative competent for the country concerned, to the Postgraduate/State Examinations office, by and no later than the mandatory deadline for enrolment, in one of the ways described above or by FAX to 059/2056574. Candidates failing to comply will be excluded.

As of 1 January 2009, all candidates who are awarded study scholarships must register with the I.N.P.S. separate fund management ("Gestione Separata") and forward the receipt issued by the I.N.P.S. office to the Accounts and Salaries Office by 15 February 2009, by fax only to 059/2057109. If PhD students are already registered with the I.N.P.S. separate fund management ("Gestione Separata") owing to previous collaboration with other institutions, they need only forward a receipt issued by the I.N.P.S. showing their registration number (by fax as indicated above).

Foreign citizens who are awarded study scholarships and do not yet hold a tax identification number ("codice fiscale") must apply for one from the "Agenzia delle Entrate" and forward a copy of the card issued by the Agency, by 15 February 2009, to the Postgraduate/State Examinations Office, by fax only to 059/2056574.

Any candidates who have not completed enrolment according to the terms and requirements indicated above will be regarded as having withdrawn.

Those candidates issuing false statements will be considered as forfeiting their right to enrolment.

Any remaining places will be assigned to other candidates, according to the order of the final merit-based ranking.

ARTICLE 8 – Reassignment of places.

In the event of vacant places, those eligible will be contacted by e-mail and/or telegram and asked to enrol, in accordance with the requirements indicated in the previous article, within a mandatory four-day time limit, starting from the day following dispatch of the e-mail and/or telegram. Failure to comply will result in loss of the right to admission.

In the event that vacant places remain as a result of all eligible candidates from the ranking being placed within a Doctoral School, candidates listed in other rankings in the same School can be transferred to the ranking in which the places become available, once an irrevocable resolution is passed by the School Admissions Board or by a body delegated by the Board, on the basis of a technical evaluation of the candidates' suitability. Those eligible will be contacted by e-mail and asked to officially enrol, in accordance with the requirements indicated in the previous article, within a mandatory four-day time limit, starting from the day following that of dispatch of the email. Failure to comply will result in loss of the right to admission.

The lists of the candidates admitted to the PhD Programmes of the Doctoral Schools for 2009 will be displayed on the Official notice board of the University and posted on the University website http://www.unimore.it, under: "Offerta formativa/Dottorati di ricerca".

The procedure will be considered complete 90 days from the day of publication on the Official notice board of the University of the list of candidates admitted to PhD Programmes of the Doctoral Schools for 2009.

ARTICOLO 9 – Scholarships

The number of study scholarships is indicated in art. 1 above. These are assigned to those eligible according to the order decided in the respective final merit-based rankings.

Merit being equal, a decision is taken on the basis of the candidates' economic situation, determined in accordance with the decree of the Prime Minister of 30 April 1997 and subsequent amendments. Candidates of equal merit will be asked to present by email and/or telegram explicit I.S.E.E. attestation (indicator of equivalent economic situation) of the I.N.P.S. so that their economic situation can be evaluated within the mandatory four-day time limit, starting from the day following dispatch of the e-mail and/or telegram. Failure to comply will result in loss of the right to admission.

The annual amount of study scholarships totals € 13.638,48 (except for subsequent regulatory amendments), and is subject to the I.N.P.S. social security contribution under separate fund management ("Gestione Separata").

Study scholarships are automatically confirmed when PhD students move onto the following year, except for a well-grounded deliberation to the contrary by the faculty board.

The payment of study scholarships is made in bi-monthly deferred instalments.

Doctoral Scholarships cannot be added to other scholarships or other forms of financial aid paid for by the University and/or the State, with the exception of those designed to be integrated with PhD student research activities, for periods spent abroad.

The amount of scholarships is increased by 50% for any periods spent abroad.

ARTICLE 10 – Fees for admittance to and attendance on PhD Programmes of Doctoral Schools

The fees for admittance to and attendance on the PhD Programme of a Doctoral School, payable by those who do not receive scholarships, are structured according to a progressive scale, with a minimum and maximum limit, as specified in the Financial Aid Application procedure provided by the Regional Agency for the Right to Higher Education - Territorial Headquarters of Modena and Reggio Emilia.

The payment of these fees is subdivided in two instalments:

- the first, payable by all candidates, to be made at enrolment (the amount of the payment slip downloadable on line includes both the instalment of € 426.31, and the government tax stamp "marca da bollo" of € 14.62);
- the second, payable by 30 April 2009 (remaining amount, dependent on the fee band assigned to the PhD student by the Financial Aid Office, subject to presentation of a special application according to the terms and requirements of the Financial Aid Application procedure).

In the event of delayed payment for either the first or second instalment, the PhD student will be liable to pay a surcharge of €51.65.

Those who wish to be placed in a specific fee band (the deadline for the submission of the relevant application is 6 November 2009) must therefore refer to the Financial Aid Application Procedure provided by the Regional Agency for the Right to Higher Education - Territorial Headquarters of Modena and Reggio Emilia for the academic year 2008/2009, available at www.unimore.it (selecting as follows: Student services" – University Study Support ("Servizi agli studenti – Sostegno allo studio"), and contact the Student Financial Aid Office ("Ufficio Benefici Studenti"), via Vignolese 671/c (University Campus), Modena.

In the event that a PhD student fails to submit a financial aid application, he/she will automatically be assigned to the last fee band specified in the application procedure indicated in this article. In this case the amount for the second instalment is €671,66).

ARTICLE 11 - Rights and duties of doctoral students

Doctoral research requires a full-time commitment, and any extracurricular activities require authorisation on the part of the Faculty Board of the School. Doctoral students are

required to carry out the research assigned to them, as well as any teaching activity and internships affiliated with the public or private bodies in the programme, in accordance with the plans and terms adopted by the Faculty Board of the School. Failure to do so may exclude the student from the programme.

The other rights and duties of the doctoral students, including incompatibility with extracurricular activities, exemption from the obligation to attend the School and the conditions of exclusion, as well as the procedure for the award of the PhD, are regulated by the norms referred to in Article 15 of the present selection procedure announcement.

ARTICLE 12 – Public employees

Under the terms of the law, upon presentation of an application, public employees who are admitted to a doctoral programme are granted leave of absence for study purposes without renumeration for the duration of the course, and receive a research grant where applicable. In cases in which they are admitted to a doctoral programme without a scholarship, or when they decline such a scholarship, they are entitled to the renumeration, insurance contributions and pension contributions pertaining to the public administration in which they are employed. In cases in which the employment relationship with the public administration is terminated by the employee in the two years after the award of the doctoral degree, the employee shall reimburse the above-mentioned remumeration and contributions.

The period of leave of absence shall be taken into account for the purposes of career advancement and insurance and pension entitlements.

ARTICLE 13 – Award of the doctoral degree

The doctoral degree is awarded upon completion of the course of study, upon passing the final examination, that the candidate may resit once only, if the examination is not passed at the first attempt.

The examination consists of an interview with the candidate relating to the subject matter of the doctorate.

The examining committee is appointed pursuant to the provisions of the University Regulations governing Doctoral Schools and Doctoral Courses.

The doctoral degree is awarded by the Rector who, at the request of the candidate, certifies the award of the degree. Authorisation of the release of the certificate is subordinated to the candidate's having handed in three copies of the final thesis to the appropriate office. Two of the copies are sent to the National Libraries of Florence and Rome and one is kept in the library of the Department which sponsored the Programme so as to ensure its conservation and consultability.

ARTICLE 14 – Handling of personal details

The University Administration, implementing the provisions contained in Legislative Decree 196/2003, undertakes to use personal details supplied by candidates solely for the completion of the competition procedures and for organisational purposes.

In accordance with the principles embodied in Legislative Decree 196/2003, participation in the competition results in tacit consent for the publication of a candidate's personal details and those relating to the admissions exam on the website of the University of Modena and Reggio Emilia.

ARTICLE 15 - Governing law

For any and all issues not specifically provided for or regulated in this application procedure, reference is made to the provisions contained in art. 4 of the law no. 210 of 3 July 1998, the Ministerial Decree no.224 of 30 April 1999, the University regulations in

force concerning Doctoral Schools and PhD Programmes, the Teaching Regulation of the University of Modena and Reggio Emilia, as well as the specific Regulations governing each Doctoral School.

The person responsible for the proceedings is the Head of Teaching and Research Office.
